### Vision

Australian native bees are valued and protected

#### Mission

The ANBA promotes the conservation, cultural significance and sustainable management of all Australian native bees.

#### Pillars

Six pillars will guide ANBA to achieve its mission

#### ANBA will achieve its mission by:

- 1. Providing education, awareness, and community support for Australia's native bees

- 3. Supporting research that enhances the health and wellbeing of native bees and/or the use of native bees in agriculture and the environment and/or development of the native bee products.
- Engaging with indigenous communities and interests for mutual exchange of knowledge
- 5. Advocating as the peak body to ensure the health and wellbeing of managed and wild native bees
- 6. Providing sustainable governance and management of the association

# Enabling and assisting branches to support active, inclusive, and respectful member communities

- 2.1. Provide communication for all branches through ANBA Newsletter, website, and other channels
- 2.2 Support and promote branch activities and their provision of community workshops and other relevant events to build awareness of native bees
- 2.3. Provide resources, infrastructure, and insurances to support branch activities
- 2.4. Offer centralised banking arrangements to minimise branch admin
- 2.5. Sponsor native bee honey competitions and provide national awards
- 2.6. Offer member discounts for workshops and conferences



Supporting research that enhances the health and wellbeing of native bees and/or the use of native bees in agriculture and the environment and/or development of the native bee products.

- 3.1. Support the progress of high priority research activities as described in the Strategic RD&E (2022-2027) Plan
- 3.2. Proactively advocate for funding opportunities and provide peak body (in-kind, seed funding, and/or endorsement) support for funding applications that enables native bee research projects
- 3.3. Promote research capacity building, through support for Cooperative Research Centres (CRCs) and other collaborations and partnerships, relevant to native bees
- 3.4. Encourage universities to include native bee activities in agricultural and environmental undergraduate courses, and facilitate postgraduate/postdoctoral research opportunities
- 3.5 Connect members, industry and researchers through the biennial Australian Native Bee Conference
